Semi-Annual Meeting with the Village Officials of College Corner, Ohio.

West College Corner council member Juanita Fenwick gave a report on the Wastewater Plant:

Juanita reported that everything at the plant is working well.

She reported on the future needs at the plant and lift station.

The Town of West College Corner, Council has applied for a USDA Planning Grant.

Reported on the Commonwealth Engineering Firm coming to the plant and listing what needs to be repaired or replaced.

The money from the ARP Grant Spending Plans.

The first issue would be on the ponds closure.

Flow meters at the lift station.

Pumps.

Chlorine Lines.

Maintenance work at the head works.

Joe Compton asked about plans on maintenance on sewer lines.

Juanita replied we need to have cameras to view the lines, town may be able to rent a camera from Liberty to view the lines.

Cost for all the work, we could sit down together and decide on cost for Ohio.

Marilyn Revalee asked about closure of the one pond, Juanita explained that all the water was taken out of the one pond, was not filled in. The Town has to dig and test the soil and then fill it in.

Ohio reported that they are starting to test Fire Hydrants.

The Indiana clerk was asked what she needs for Sewer late payment.

Clerks reply.

1. A list of customers who are 90 days behind in payments.
2. The clerk will then send a past due statement to the customer, if the customer is a renter the property owner will get a copy of the past due billing also.
3. If the bill is not paid by due date the clerk will put a sewer lien on the property owners Property Taxes.


The Indiana Clerk will meet with Mike Ruther to show what she needs for the 30 days past due billing.
