Then there will need to be a change in the ordinance on billing.

Then there will be a need for a new rate study to be completed.

Also will need to check to make sure no water was getting into wastewater lines on both sides.

Juanita discussed the attorney fee of \$ 7,984.00 for the law suit filed by the Village against West College Corner, Indiana.

Juanita stated she was told by two College Corner, Ohio Village Council people the Village of College Corner, Ohio would pay the attorney fees from the law suit for West College Corner, Indiana and they have not. Jennifer Woods, Josh Hankins and Wes Cedar agreed with Juanita's statement.


Council also discussed the Mutual Aid Agreement:
