Street Commissioner- Mr. Hankins is absent.

Village Administrator- updates were give all aspects of the water and sewer operation. Mike Sims and Mike Ruther went to the Town meeting on February 16, 2023 to let them know they will need to begin paying for billing as well as to have the covered valves replaced that were paved over. The attorney for West College Corner stated the addendum could be added to the agreement to pay for billing. Mr. Sims contacted the attorney and no return call. Job posting for a maintenance worker and office assistant have been posted and applications are due by March 31, 2023. The notice was also on the website about the job postings. There is a new customer on Kingery Road for water as their well went dry. There was an

issue with some transponders and Badger is working with the cellular provider to resolve the issue. Landscaping around the building needs to be started and finished this spring and summer, working on funding for the Paxton Ditch, preparing for the ODNR project and going to perform a rate study.

Ms. Woods stated the Council will need to begin to list items or project they want to spend the SLRF funds on and get the project started. Ms. Woods has mandatory training for two days.

Mr. Ruther moved to accept Graydon, Head and Ritchey LLP as the legal representation for the Village. Mr. Cedar seconded the motion. Vote: 4:0 in favor. Motion carried.

Deputy Essell entered the meeting at 9:46a.m. Deputy Essell resigned from the Butler County Sheriff's Office. Deputy Essell thanked Jennifer Woods and Mike Sims for all of the help since he arrived in the Village. Deputy Essell said he will be back to visit and he was so happy with serving as the Deputy for the Village contract. Mayor Jackson and the Council want it noted their appreciation of Deputy Essell and how professional and well his time at the Village was served.
