B. Approval of Minutes/Bill

Mr. Ruther moved to approve the minutes for the regular meeting on August 10, 2023 as presented. Mr. Bake seconded the motion. Vote: 4:0 in favor. Motion carried. Mr. Ruther moved to approve the bills for August 2023. Mr. Cedar seconded the motion. Vote: 4:0 in favor. Motion carried.

C. New Business/ Old Business/Continual Reports

NEW BUSINESS

Alta Fiber representatives informed the Council they will be in College Corner by the end of 2024.

Mayor Jackson appointed resident Michael Rogers to Council to serve the term which will expire on December 31, 2023. Mayor Jackson conducted the oath of office. Mr. Bake moved to approve the appointment of Michael Rogers to Council. Mr. Cedar seconded the motion. Vote: 4:0 in favor. Motion carried.

Engineering Services Agreement with JWCI for the Franklin, Preble, Butler Street Project. Mr. Bake moved to approve the Engineering Services Agreement with JWCI. Mr. Ruther seconded the motion. Vote: 5:0 in favor. Motion carried.

Mr. Bake moved to adopt and accept Ordinance 2023 B. Mr. Cedar seconded the motion. Vote: 5:0 in favor. Motion carried.

Leaf collection dates will be October 28, 2023-December 9, 2023.

Trick or Treat will be October 31, 2023 from 6pm-8pm.

Old Business

Recycle bins- quote was around \$1200 just to install cameras. Council will not proceed at this time.

Continual Reports

Property Updates- Mr. Cedar reported that 106 Monfort has some improvement and Patti Rush will be working on having the truck and boat removed. The weeds are still an issue. 200 Monfort Street is still a mess but some items have been removed. 106 County Line Street- there was a formal complaint made to Mr. Cedar.

Street Commissioner- not in attendance. The Council will proceed to collect sealed bids for the red truck. Mr. Bake moved to accept sealed bids for the red truck and the Fiscal Officer will manage the project. Mr. Cedar seconded the motion. Vote: 5:0 in favor. Motion carried.



Adjournment


